

ORDINANCE NO. 2017-146

AN ORDINANCE AUTHORIZING COMPENSATION, SALARIES AND WAGES TO EMPLOYEES OF THE ASHTABULA CITY MUNICIPAL COURT AND PROBATION DIVISIONS.

WHEREAS, the daily operations of the City of Ashtabula and the public's peace, health and safety require the enactment of this ordinance; and

WHEREAS, the judge of the Ashtabula Municipal Court has prescribed the annual compensation for the employees of the Ashtabula Municipal Court and Probation Divisions attached hereto; and

WHEREAS, the three fifths of the wages for the Judge, Clerk of Courts and Bailiffs of the Ashtabula City Municipal Court are paid from the City treasury; and

WHEREAS, it is necessary for this Council and these Public Officers to adopt legislation to provide for the compensation, salaries and wages to all employees of the City of Ashtabula, the Ashtabula Municipal Court and Probation Divisions; and,

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Ashtabula, Ohio:

SECTION 1. That all employees of the Ashtabula Municipal Court shall receive from the City treasury the following compensation, wages and salaries effective 12/04/2017 (note: all amounts are in dollars unless otherwise indicated):

SECTION 2. Employees of the Ashtabula Municipal Court and Probation Divisions will receive from the City treasury the following annual stipends and performance bonuses in fiscal year 2018:

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and related to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with the requirements of Section 10 of the Municipal Charter of the City of Ashtabula, Ohio, and of R. C. Section 121.22.

SECTION 4.

For the reasons stated in the preamble, this ordinance, if approved by the votes of five (5) or more members of Council, shall take effect immediately, otherwise 30 days thereafter.

Nick Dearing will receive \$2,500.00 to be paid out of Court Computer fund 215 on May 1st, 2018


Katherine Kasputis salary will be paid by Court Special Projects 412
