

ORDINANCE NO. 2017-59

AN ORDINANCE AUTHORIZING COMPENSATION, SALARIES AND WAGES TO THE DIVISION OF POLICE EMPLOYEES OF THE CITY OF ASHTABULA.

WHEREAS, the daily operations of the City Manager's Department and the public's peace, health and safety require the enactment of this ordinance; and

WHEREAS, it is necessary for this Council and these Public Officers to adopt legislation to provide for the compensation, salaries and wages to all employees of the City of Ashtabula Division of Police; and,

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Ashtabula, Ohio:

SECTION 1. That all Police Department employees of the City of Ashtabula, Ohio shall receive the following compensation, wages and salaries effective 04/24/2017 (note: all amounts are in dollars unless otherwise indicated):

SECTION 2.

It is hereby found and determined that all formal actions of this Council concerning and related to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with the requirements of Section 10 of the Municipal Charter of the City of Ashtabula, Ohio, and of R. C. Section 121.22.

SECTION 3.

For the reasons stated in the preamble, this ordinance, if approved by the votes of five (5) or more members of Council, shall take effect immediately, otherwise 30 days thereafter.
