### **CITY MANAGER'S REPORT**

### **Waste Water Treatment Receiving Station**

The City Manager requested an ordinance to enter into an agreement with Ashtabula County Roto-Rooter of 708 West 30th St, P.O. Box 524, Ashtabula, OH 44004 as the low and most responsible bid for the Waste Water Treatment Receiving Station, in the amount not to exceed \$14,875.00. Funding for this expenditure will be taken from Account Number 503-150-5500, Water Pollution Control, Capital Improvements. Mrs. Lattimer moved, Mr. Trisket seconded to grant the Manager's request. The Ward 4 Councilor said she likes to see Ashtabula companies being awarded City work. The motion CARRIED.

#### **Electric Rate Provider**

The City Manager requested an ordinance to enter into an agreement with First Energy Solutions of 341 White Pond, Akron, OH 44320 as the low and most responsible proposal for electric rate provider for City Buildings in the amount as listed on the attachment (to the Manager's). Mr. Trisket moved, Mrs. Lattimer seconded to grant the Manager's request. The Manager reported the City is currently in a contract, scheduled to expire in July. The City is being proactive to make sure everything is in place prior to the contract expiration. The President asked if the rates are lower or higher. The Manager responded they are higher. In 2015 the City will see a large capacity charge increase from electric providers in Ohio. This 33 month contract helps to mitigate the large increase we will see in the future by paying a little more now and less when the large increase is assessed. The motion CARRIED.

# **Early Retirement Incentive Plans**

The City Manager requested AN ORDINANCE AUTHORIZING THE CITY MANAGER TO WAIVE CERTAIN LIMITATIONS ON PAYMENT OF BENEFITS TO PERSONS WHO ENTER THE EARLY INCENTIVE RETIREMENT PLANS OF THE CITY AND RETIRE ON OR BEFORE JULY 31, 2013, AND RETIRE ON OR BEFORE AUGUST 31, 2013. Mrs. Lattimer moved, Mr. Pugliese seconded to grand the Manager's request. The President sought clarification and asked if the plan gives employees who are eligible to retire the incentive to do so in order to reduce the City's financial obligations to them for the last quarter (plus), of the year. The Manager replied, yes. The motion CARRIED.

### **Submerged Land Agreement**

The City Manager requested an ordinance to enter into an agreement with Grant Brockway to lease submerged land in the Ashtabula River for the purpose of a grant application. Mrs. Lattimer moved, Mr. Trisket seconded to grant the Manager's request; motion CARRIED.

### **Applications of Grant Funding through Ohio Development Services Agency**

The City Manager requested an ordinance authorizing the City Manager to file applications for grant funding for the following available grants; Community Development Program's Downtown Revitalization, the Critical Infrastructure Grant, and the Community Development Allocations Grant. Mrs. Lattimer moved, Mr. Trisket seconded to grant the Manager's request. The Manager reported the Harbor will be the target area because of the significant amount of private investment happening in the area in the next year or two. The private funds may be used as match funds towards the City's grant match. The grants have become much more competitive. Extra scoring points are obtained where public and private funds are being expended. The specific projects have not been chosen. There will be public hearings prior to submitting applications. The President asked if the activity will be coordinated with the Poggemeyer Design Group's plan and the Lift Bridge Community Association's (LBCA) Big 3 Plan, as it relates to sharing resources. The Manager responded that Char from Poggemeyer will assist in the grant application process. The motion CARRIED.

### Walnut Beach Concession Restroom Improvement Project Change Order No. 1

The City Manager requested an ordinance to execute Change Order No. 1 with Feghali Brothers Construction and Engineering, of 4636 Beech Court, Canfield, Ohio 44406 to include Alternate item No. 2 of the bid in the amount not to exceed \$15,500.00. Funding for this expenditure will be taken from Account Number 290-180-5425, entitled Revolving Loan Funds. Mrs. Lattimer moved, Mr. Pugliese seconded to grant the Manager's request. The Manager announced the project will begin Wednesday. The change order addresses Alternate 2 in the plans to allow the "sea green" concession stand color to be painted anew. The President asked what the total project cost will be. The Manager responded the contract was let for \$122,500, and added to it was the added \$15,500 for the painting. The motion CARRIED.

# Modification of a Community Reinvestment Area Tax Incentive Agreement

The City Manager requested an ordinance to enter into a Modification of a Community Reinvestment Area Tax Incentive Agreement with First Ashtabula Mining Company and the Ashtabula Port Authority in an effort to extend the construction completion date. Mrs. Lattimer moved, Mr. Pugliese seconded to grant the Manager's request. The President asked for the extension date. The Manager responded March 1, 2014. The project is the Ashtabula Hotel project which will become Signature Health's new location. The motion CARRIED.

### QUESTIONS AND/OR COMMENTS FOR THE CITY MANAGER

### Walnut Beach Concession Restroom Improvement Project Change Order No. 1

The President asked about the funding. The Manager said the entire project is being funded by the City's Revolving Loan Fund (RLF). The State requires that the City spend the money in order not to get into the situation the City did a while ago. He reported Planning & Community Development Department Project Administrator Mary Church, he and the department discussed what projects could be done, identified Walnut Beach, and asked the State's permission to use RLF, which they approved. The President commented that RLFs may not be used for various projects, purchases, general operations, and payroll like income tax revenue may be used for. A project that would greatly benefit for the community was identified, and will improve a much used facility. The Ward 4 Councilor asked the Manager to detail the project. The Manager responded:

- \* A complete renovation of the restrooms;
- \* Restrooms will be made accessible when the concession stand is closed, and secured at an appointed time by automatic timed locks; and
- \* The concession stand area will be painting.

### **City Manager's Report (cont'd)**

# West Avenue Overpass Resurfacing (Over West 30<sup>th</sup> Street and the Railroad)

The Manager announced construction will begin on Monday, May 13, with a projected completion date of Wednesday, October 16. Traffic will be able to use the overpass, but with fewer lanes. He does not believe traffic travelling under the overpass, at West 30<sup>th</sup> Street, will be affected.

### **Leaf Bag Pickup**

The City Manager reported leaf bags will be picked up free for one more week in all wards but the Harbor. Because the pickup season began April 15, the Harbor had two free pickups; wards had one. Next week pickup will be in the Harbor, and stickers will be required.

### Transfer Station Open on Saturday, June 1

The Manager reported the Transfer Station will be open to City residents on Saturday, June 1, from 8:00 a.m. until 2:00 p.m., to dispose of items at the established rate; to get a new digital thermometer when a mercury thermometer is turned in to help keep mercury out of the City's water supply, and 10 standard car and truck tires will be allowed to be disposed of free; thereafter a per tire charge will be assessed.

### QUESTIONS AND/OR COMMENTS FOR THE CITY MANAGER (cont'd)

**East 48**<sup>th</sup> **Street Park:** The Ward 4 Councilor reported a resident asked her who owns the park because the resident would like to raise funds to perform improvements. Mr. Earl Tucker, Ashtabula City Parks & Recreation Board Chair, has been given the resident's name and will take over from here.

Procedure for Disposal of Furniture: The President asked the Manager to outline the procedure because of all the furniture he sees on treelawns which he knows our Sanitation Department is not required to pick up with regular garbage collection. The Manager said this is a big problem, mostly at rental units. The ordinances say if the City picks it up without begin notified the minimum cost is \$75. If residents would make arrangements by calling the Sanitation Department Foreman or Public Services Superintendent the cost will be lowered and City departments will not get calls that the town looks like trash because of treelawn dumping. He asked landlords to stress this with their tenants. The President cited a violation of this type at Route 20 and Park Avenue.

**Grass Clippings:** The President asked the Manager to outline the procedure. The Manager asked that grass clippings not be mowed or placed in the street. He suggested grass and leaves are either mulched on the property or collected and bagged - realizing some may go into the street. Intentional placing of grass clippings in the street (which is common) clogs the storm drains and sewers. The law permits the City to issue citations, penalties, and fines to violators.

**Street Sweeper:** The Manager reported the sweeper is out; the main arteries have been targeted, and wards are next.

**City Appearance:** The President said this time of year flowers are blooming (noting that Ashtabula Metropolitan Housing Authority (AMHA) has a beautiful display of tulips), but that litter and refuse totally takes away from the community's beauty. He asked citizens to pick up their litter, any they may see when passing by, and not to discard cigarette butts out vehicle windows. If we all work together it will be a minimal amount of work for each of us and will make a big impact on the overall appearance of the City.

### **MISCELLANEOUS BUSINESS**

**East 48**<sup>th</sup> **Street Park:** The Ward 4 Councilor reported the City maintains this park, she believes the property belongs to the City but it is not on the City's list of parks, and asked the Manager to check into ownership to make sure who the owner is so residents may raise funds for upgrades to the park.

**Park-to-Park Clean Up:** The President announced a community clean up of South Park and LCpl Kevin M. Cornelius Park (formerly North Park) is scheduled for Saturday, May 25 and Sunday, May 26, from 8:00 a.m. to 2:00 p.m.

**Public Hearing:** The President announced Council will meet in a Public Hearing on Monday, May 20, at 5:30 p.m., in Council Chambers, to hear public comments regarding a request to rezone Thistlewood Apartments, on Carpenter Road, from R-3/Two Family Residence District to R-4/Multiple Dwelling District. The Ashtabula City Planning Commission has heard the request and voted 3 to 2 to approve it. The Ward 3 Councilor said she has never seen a Planning Commission split vote like this one.

**Primary Election:** The President announced tomorrow is Ashtabula County's Primary Election day; encouraged residents to vote; and encouraged a YES vote on the consolidation of the Treasurer and Auditor Departments into a Department of Finance to help streamline operations save funds, and operate more cost effectively. The City Auditor reported since her hire in 2012, improvements have been made with existing and new staff, some problems have been fixed, that she is working with Treasurer Mackey to move the department forward, and to be assured that the internal control concern will be taken care of. The President reported the Treasurer and Auditor support the consolidation and have written to the public showing their support.

The City's 1.8% City Income Tax is scheduled for its 3 year renewal. The revenue from this tax is more than 60% of the General Fund operating dollars. Without it the City most assuredly could not operate near the level it does at present. He asked that citizens vote YES to help fund police & fire departments, administrative offices, and partially fund the Departments of Health and Planning & Community Development.

The President announced that the Ashtabula Area City Schools will have an emergency levy issue on the ballot.

The Ward 4 Councilor reported major cuts and plans for the future of the City have been made. She thanked the City Manager for all that he has done to successfully negotiate changes in bargaining agreements, (e.g., employees now pay a portion of their monthly health insurance premium), departments have been reorganized, and the enactment of an early retirement incentive (not all positions vacated by retirements will be replaced). The Councilor also thanked the City Auditor for her invaluable contributions to these changes.

The President noted that even if the income tax is renewed, local governments continue to face State cuts, therefore will operate with less, even still.

### **GENERAL PUBLIC DISCUSSION**

Ms. Shelia Young, 516 West 46<sup>th</sup> Street: Said she has lived at her current residence for 22 years, and had to go through three City Managers before the house next to her was condemned. She said the roof of the condemned property is falling into her driveway on her car; she has a paralyzed daughter; the debris falls with each storm/rain; and she mows the grass at the condemned property.

Ms. Young said the house next to the condemned property (514) was abandoned after the homeowners passed away. It is being broken into, windows are broken out, she mows this lawn too, and cleans all West 46<sup>th</sup> Street cutters, because she cares about her neighborhood. She would like the (512) structure razed.

The Manager said he believes the Planning & Community Development Department has a few houses on the demolition list in the West 46<sup>th</sup> Street area. He said the City awaits information from Ashtabula County, who is overseeing the bid process in connection with the "Moving Ohio Forward" funding. The City of Ashtabula was granted \$200,000, and hopes to raze 10 to 15 more homes.

Ms. Young reported Seeley Medical pulled into the driveway, had some of the roof fall on their vehicle, and they asked who they should sue.

The Manager said he will look into this.

The President thanked Ms. Young for attending the Council meeting and addressing this issue. He said he is on West 46<sup>th</sup> Street frequently, knows there are wonderful families on the street that try and watch out for things, and knows there have been a lot of drug and crime problems on the street. He said he spoke with her daughter today, and wanted to clarify that her disability was not caused by the roof falling on her. Ms. Young assured him it was not.

The President said the City of Ashtabula's housing problems are plenty and that it is sometimes hard to tell which homes are worse than the next, but has confidence in the Planning & Community Development who is really trying to stay on top of things. He said if the City is unable to raze the structure Ms. Young speaks of, the City will at least try and make the property owner accountable to make sure it is safe so as not to cause damage or harm to anyone on her property.

Mr. John Mulholland, 218 West 55<sup>th</sup> Street: He thanked the City for razing the house on his street (which is the one the tree had fallen on). He said people were going in and out of the vacant structure and drugs were an issue. He said it really looks nice now; people are beginning to work on their houses again; cleaning their yards; and planting flowers. He said he is impressed; and that he attended a Council meeting 5 to 6 years ago and was not impressed. He said, "Seems like we have a good team of Council people that really work together. Just sitting here watching I'm quite impressed with my City Council. Very enthused and happy to be a part of Ashtabula and see how you work so well together".

The President said local officials are always looking to improve and "sure are trying". He thanked Mr. Mulholland for his time.

Ms. Melinda Pillsbury-Foster, 525 Bunkerhill Road: Explained the "Green Home" concept, a concept of McPherson Investing, the firm she is affiliated with. The construction materials that are used eliminate the need for heat or cooling devices. She hopes to work with the City (and possibly the county) to acquire some vacant properties. Most of the properties she is interested in are vacant because the City of Ashtabula, through use of Neighborhood Stabilization Project funds, razed the houses due to their blighted condition. McPherson Investing would also like to open a factory in the City for the production of the materials needed to construct the homes. Ms. Pillsbury-Foster commented on the wonderful assets Ashtabula County has but are not being utilized. She was asked to email the City Manager her specific needs to ensure everyone is on the same page, and so he can share the information with others for the purpose of getting her the information she needs in order to move forward.

The President thanked Ms. Pillsbury-Foster for attending the meeting.

**CLOSING REMARKS** 

Karen Flack: The President extended get well greetings to Karen, a regular attendee at this

meeting, who is not feeling well.

**EXECUTIVE SESSION** 

The President entertained a motion to convene an Executive Session to discuss Personnel/Employment. Mr. Trisket moved, Mr. Pugliese seconded to convene the Executive Session for the stated purpose. On the roll call to convene the Executive Session: Mr. Trisket, Mr. Pugliese, Mrs. Lattimer, Mr. Balog, Mr. Ducro voted yea; motion CARRIED. Also present in

the session was the City Solicitor and the Clerk of Council.

The President announced there will be no business to conduct after the Executive Session, but

that Council would return to open session to adjourn the meeting.

**Reconvene Public Meeting** 

At 9:04 p.m., the President announced Council returned to the public portion of the meeting;

and that there was nothing to report out of the Executive Session.

**ADJOURNMENT** 

Mrs. Lattimer moved, Mr. Pugliese seconded to adjourn the meeting at 9:05 p.m.
