PURPOSE: The Council President announced the purpose of this Public Hearing was for the presentation of the 2014 City of Ashtabula Tax Budget.

WELCOME: The President welcomed Messrs. Earl Tucker and Richard Quaranta.

DISCUSSION

The City Auditor reported:

- * The Tax Budget is a municipality's way of notifying the county it wants the property tax revenue indicated and certified to it;
- * Our 2014 request is based on certification notification received from the county, and our property valuation;
- * \$1,990,000 (one million, nine hundred, ninety thousand) was certified; we are requesting the full amount;
- * Our 2014 tax budget mirrored much of 2013's;
- * Our tax budget request is based on information we have at the moment (e.g., staffing and items we know will come up next year), but there were some adjustments;

- * The county certified about \$87,000 more than they did this year;
- * Our property valuation increased by almost \$10,000,000 (ten million dollars). The President commented, "That's staggering". The Auditor said she does not know why, but that is what was received from the county;
- * Some of the 2013 revenue will not be available in 2014; therefore it kind of balances out and causes us to have to sweat less.
