General Statement of Duties:

Performs chemical, bacteriological and physical tests and analysis of raw, partially treated, and treated wastewater and by products to determine efficiency of plant processes and insure that the plant effluent meets local, state and federal requirements. Also, tests industrial discharges to determine compliance with the Industrial Pretreatment Ordinance.

Examples of Duties and Responsibilities:

Performs any combination of laboratory tasks such as the following: Collects samples of plant influent, partially treated wastewater, effluent, sludge, and other plant by-products. Assembles instruments and equipment for analytical or research work. Prepares chemical and bacteriological media, strains, reagents, and test solutions routinely used in laboratory. Operates equipment and conducts tests as directed by the NPDES Permit and by the Plant Superintendent. Maintains test result records, prepares data sheets. Prepares or assists in the preparation of reports. Cleans, maintains and stores instruments and equipment. Maintains inventory and orders supplies and equipment. Performs custodial duties in laboratory. Operates laboratory under direction of Chief Laboratory Technician. Performs other tasks as assigned.
