

Official Rules: City of Ashtabula Go Paperless/Auto-Pay/Registration Sweepstakes

NO PURCHASE IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. Purchase will not increase your chances to win. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of Invoice Cloud, Inc. (the "Sponsor") as final in all matters relating to this Sweepstakes.

Eligibility: Sweepstakes is open to legal U.S. residents from 4/1/2018 to 05/31/2018. Each time you do one of these three things for the first time between 4/1/18 and 05/31/18, you'll be entered in the sweepstakes. The maximum number of entries per account is three. The Invoice Cloud service website's database clock will be the official time keeper for the Sweepstakes. Internet entry must be made by the entrant, only at the City of Ashtabula payment portal.

If you would like to enter the sweepstakes other than through enrolling in Auto-Pay, Signing up to Go Paperless, or registering for an account on the City of Ashtabula payment portal, you may do so by sending a 3x5 card with the hand printed words: City of Ashtabula Sweepstakes, your name, address, telephone number, and the bill account number for which you are entering.
